### *Pre-Authorize Automatic Monthly Debits*

We are an active healthy Catholic faith community, which serves Catholic people in the Swift Current area. Donating to Christ the Redeemer Parish by the Pre-authorized monthly debit gives you a very easy method to make tax-deductible donations to support our Parish Community.

#### *How the Pre-Authorized Monthly Debit Works?*

- \* Complete the form, which authorizes your bank or Credit Union to forward to Christ the Redeemer Parish your designated donation (this is a one-time application- you only need to sign up once.)
- \* Christ The Redeemer Parish will receive the amount you have authorized on the 15<sup>th</sup> &/or the last day of each month as you have indicated.

#### *The Advantages of the Pre-Authorized Monthly Debit*

- ✓ You will no longer have to bring cash or cheques to mass or have to put anything into the collection basket at mass.
- ✓ Christ the Redeemer Parish will have cards available at the kiosk, which you may put into the collection basket if you feel more comfortable in doing so. These anonymous cards will state that you donate by your pre-authorized monthly debit.
- ✓ Christ The Redeemer Parish will save money by not having to provide you with collection envelopes.
- ✓ Christ The Redeemer Parish will have a more stable monthly cash flow in order to continue providing programs and services.

#### *Income Tax Receipts*

You will continue to receive your income tax receipt at the usual time of year. Your receipt will indicate the amount you gave, including the Special Ordered Collections as you have indicated.
